- Leona Turra expresses the support of Snowgums Body Corporate for Ice Skating Rink, with conditions such as no lights on after 9pm. Queries noise from generator.

4.0 GENERAL BUSINESS

Elaine Burridge responded to questions on General Business and Projects Pipeline.

- Document answering questions from previous DPAC meeting regarding 'Other Business' distributed prior to meeting
- Future of DPAC: DPAC to continue into the New Year to allow new Council to decide on its future

RECOMMENDATION: DPAC requests to have a meeting with Council regarding their contribution to the community

- Simon Jones has been planning improvements to the Toboggan Slope to be implemented before winter, including signage and pedestrian access
- Concrete improvements at Castran Corner complete
- NBN coming to Dinner Plain in early 2017, with tower to be installed by NBN, possibly before the end of 2016
- Colin MacDonald raises the issue of the back access road behind the toboggan slope. It needs completing and additional parking
- Leona Turra suggests the need to schedule DPAC meetings to align with the Finance Reports
- DPAC requests Council review the Stockman Project lease on Sphagnum Moss offsets and review the price paid as well as the possibility that those offsets can be used by the village itself for development (such as Village Green).
- Lee Rourke provided an update on new investment in Dinner Plain, including Ramada, the old Cilantro and the Onsen.
- Belinda Trembath provided an update on Hotham Airport. Talks being held with Essendon Fields. Search for a Dash 8 continue.

ACTION: Will Jeremy to provide information on the use of Sphagnum Moss offsets



RECOMMENDATION: DPAC makes recommendation that the community be advised about leases in Dinner Plain

- Belinda Trembath suggests Dinner Plain and Hotham marketing meet to coordinate Opening Week this year.
