# Ovens Fire Complex Community Wednesday 29 January 2020

#### **Fire Situation Update**

## Total Area of Ovens Fire Complex - 102462ha approx.

The fire is generally quiet and is not exhibiting much fire intensity.

Crews on the ground are presently working on hotspots located at Carboor East, Nug Nug and Upper Rose River area.

Hotspots around the perimeter continue to be actioned as they are identified by aircraft recon and ground crews.

Crews and heavy machinery continue to work on road and track network re-opening and hazardous tree treatment.

As the fireground becomes drier, smoke from inside the fire perimeter will be visible to the public as unburnt areas well within control lines continue to burn out.

#### **Community Meetings**

There are currently no community meetings planned at this time. Regular updates are being published on the DELWP Hume Facebook page to keep residents informed.

#### **Thursday January 30**

Hot and mostly sunny. Area of smoke haze in the east. Light winds. Daytime temperatures reaching 33 to 40.

#### Friday January 31

Very hot and becoming humid. Mostly sunny day. Winds will be north to north-easterly during the morning 15-20 km/h. During the day the winds will be north to north-westerly. Daytime temperatures reaching 36 to 44.

#### SUMMARY OF FINANCIAL ASSISTANCE: Emergency Bushfire Response in Primary Industries \$75,000 Grants

This program helps pay for the costs of clean-up and other emergency measures including:

- repairing or replacing fencing and horticultural netting
- disposing of dead stock
- rebuilding or replacing damaged or destroyed on-farm infrastructure
- additional labour costs and more.

Claims can be made for activities/costs incurred since the date of the event.

#### **Transport subsidy:**

This program covers 50 per cent of the total freight costs to a maximum of \$15,000 (excluding GST) per farm business. Applicants can apply for a combination of the following transport activities:

 transport of emergency fodder for stock to fire-affected properties





- transport of stock to agistment, including returning stock
- transport of stock to sale or slaughter
- transport of emergency stock drinking water.

Claims can be made for activities/cost incurred since the date of the event. A maximum distance of 1,500 km applies per movement of stock and fodder and 500 km per movement of water. A minimum load of 20 dry sheep equivalents applies for movements of stock (loads of less than this will be assessed on a case by case basis). The minimum load for water and fodder is 500 kg.

#### **Emergency Water Relief Program**

If you have water contamination due to bushfire. Eligible residents will be provided a tank water flush and 5000 litres of water. South East Water are facilitating this program for the north east fires. Call 131 851 for further information.

#### Flying drones near emergencies

Emergency situations can be dangerous for people, property and the environment. Flying your drone near emergencies can cause major safety risks to response teams both in the air and on the ground. While it might be tempting to take footage, doing so could break the drone safety rules and affect rescue efforts. If you fly –they can't. Someone's life could be on the line. To protect yourself and the safety of others, unless you have specific permission, never fly your drone in or near natural disasters such as bushfires.
